13 My name is Susan Langdon. I am the Director of
14 Projects and Finance of the Niagara County
15 Industrial Development Agency, and I have been
16 designated by the Agency to be the hearing officer
17 to conduct this public hearing

18 We are here to hold the public hearing on
19 the CRS Truck & Trailer Services, Inc. and/or
20 individuals or affiliates, subsidiaries or entities
21 formed, or to be formed, on its behalf. The
22 transcript of this hearing will be reviewed and
23 considered by the Agency in determination of this

1 project. Notice of this hearing appeared in the
2 Niagara Gazette on August 11, 2017.

3 The proposed project consists of the
4 expansion of the company's facilities to establish
5 an on-site wastewater treatment plant, boiler system
6 and compressor air system. The expansion will also
7 entail the construction of a 1,600 square foot
8 addition to the existing building to house specific
9 tote wash equipment.

10 The proposed financial assistance
11 contemplated by the Agency includes New York State
12 and local sales and use tax exemption benefits,
13 mortgage recording tax exemption benefits, and real
14 property tax abatement benefits in compliance with
15 the Agency's uniform tax exemption policy.

19 period closes on September 8, 2017.
