The plant at the Somerset location bottles fruit juices, ice teas and other beverages on its hot fill line. Operations also include four apple press machines to accommodate bulk apple juice sales as well as bottling of apple cider on its cold fill line. There is significant warehouse space including three controlled atmosphere cooler rooms.

Mayer Bros. inception of its operations began in West Seneca, NY in 1852, and has been at the Somerset location since 1986. This building expansion planned in Somerset will provide additional juice bottling production and distribution space. The expansion will almost double our existing production area and will allow Mayer Bros. to add a second bottling line to keep up with new customer demands. The expansion will also enable the Company to increase its' efficiencies and enhance its quality assurance standards. An additional three loading docks will facilitate efficient pickup and delivery of finished products. Improved operations as a result of this expansion will enable Mayer Bros. to achieve additional economies of scale by saving on labor and overhead costs per case to be more competitive in the market place.

Your eligibility determination will be based in part on your answer (attach additional pages if necessary): _____ To improve Mayer Bros.'s efficiency and competitiveness while meeting increased demands from current and potential new customers Mayer Bros Company is analyzing the feasibility to construct a 40,400 sq. ft.+/- building at 7389 Lake Road in Somerset, NY. This structure will be an addition to our existing building and will be used for juice bottling and distribution operations. The addition of approximately \$2,000,000 of equipment and machinery to construct a hot fill bottling line will be the main component of this new building. Sales to customers for their private label business is very competitive and to win new bids and maintain existing business cost containment is a must. Efficiencies to produce products faster and less expensively are continually strived for. Due to these highly competitive industry conditions and increasing costs of doing business, this project needs the assistance of the NCIDA to make this investment a feasible one for Mayer Bros. The result of this investment will allow Mayer Bros. to not only grow, but also keep workers employed during previous slower months.

Mayer Bros. currently bottles water, cider, juices and other beverages for various customers including Wegmans, Tops, C&S, Wal-Mart, Sam's Club, Giant Eagle, Arizona Beverages, the USDA and others. A majority of our products are sold outside of Niagara County and over 60 percent are sold outside of New York State. Preliminarily, Mayer Bros. anticipates the initial addition of 14 jobs for one shift to accommodate the new production line operations. The overall objective will be add 26 jobs and run two shifts within a year of the initial start up date.


