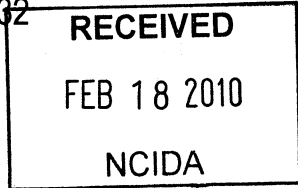



## ADDENDUM A

### Niagara County Industrial Development Agency Application for Assistance

#### Retail Project Certification

The undersigned, hereby certifies the following:

1. An application for financial assistance from the Niagara County Industrial Development Agency (the “Agency”) has been submitted by Timothy J Hannon, (the “Applicant”) with respect to a certain Project, as described in the Application for Assistance, (the “Application”) to which this Addendum is heretofore attached.
2. 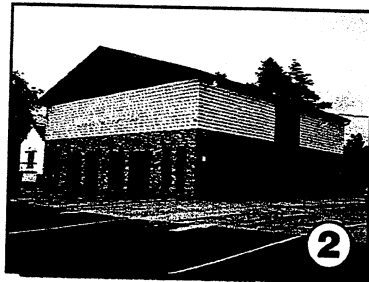
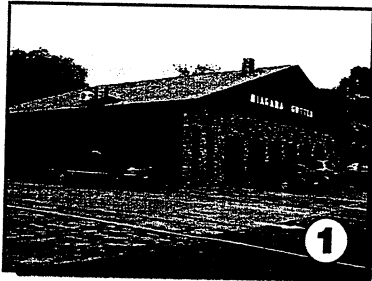
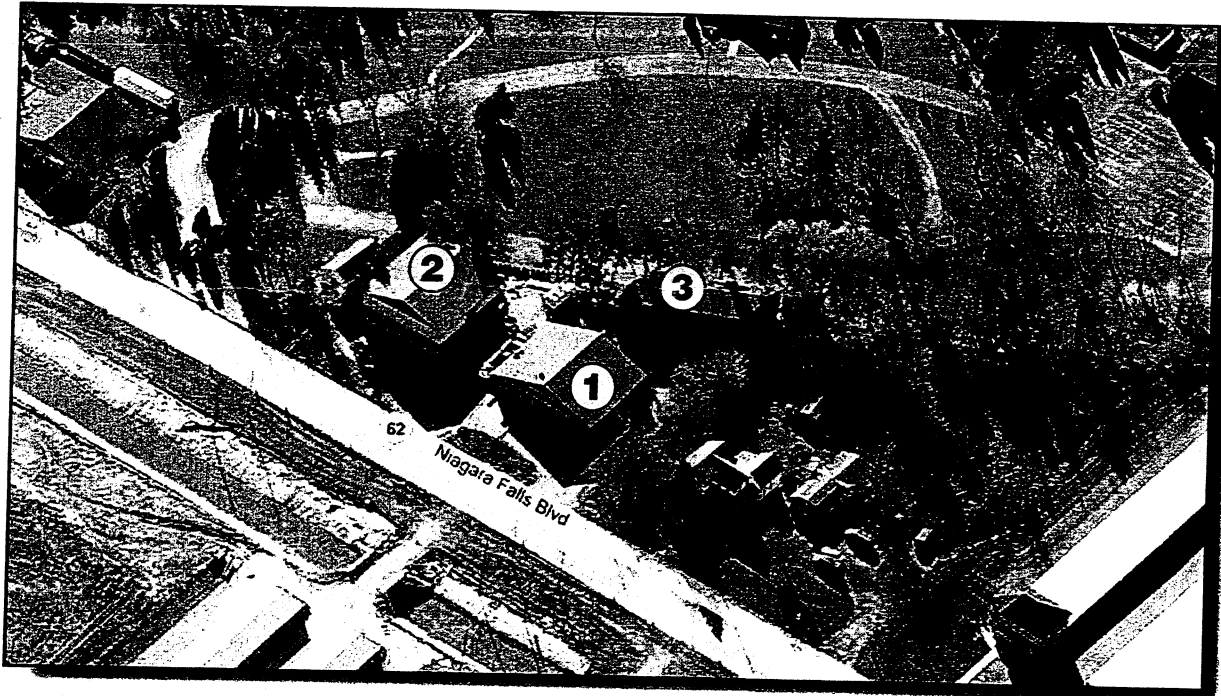
PROPOSED LAYOUT
