5.0 Approval of NCIDA Meeting Minutes

5.1 Meeting Minutes of March 9, 2016

6.0 NCIDA/NCDC/NADC Committee Reports

6.1 Finance & Audit Committee

6.1.1 2015 Audit Report

Sara Dayton, CPA, from Lumsden & McCormick, LLP, CPAs, handed the Committee Members binders titled "Presentation to the Audit Committee" which summarized all of the agency audits for FYE December 31, 2015.

Ms. Dayton summarized the audits and stated that all were clean with no findings nor material weaknesses. There were no "findings" which means the audit was "unmodified." She went through each audit, the NCIDA, NCDC, NADC, NEDF and lastly the NIIA and discussed the various compliance reports, special purpose statements, partnership returns, independent auditors' opinions, etc.

Ms. Dayton then briefly touched on fees, program income, rental and occupancy income, administrative fees, grants, and gave a brief discussion of the Governmental Auditing Standards Board (GASB 77).

After further discussion, Mr. Wolfgang motioned to accept the Annual Audit; Mr. Brady seconded the motion. The motion passed unanimously.

6.1.2 March Agency Payables

Mr. Onesi stated that he had reviewed the monthly payables and found them to be in order.

7.1 H. Sicherman & Co. – Consulting Services Agreement

Ms. Langdon had reported last month that staff circulated a Request for Proposals ("RFP") to provide services associated with the planning, funding, and implementation of the Niagara County Industrial Development Agency's community and economic development programs.

The RFP was mailed to fifteen (15) consulting firms in Erie and Niagara Counties, and also Women and Minority owned Business Enterprises. A display advertisement also appeared in the February 13, 2016 edition of the Niagara Gazette.

We received one proposal in response to the solicitation, from H. Sicherman & Co. Staff recommended acceptance of this proposal which was attached for the Board Members' consideration.

Mr. Brady made a motion to accept the Sicherman RFP; Mr. Ross seconded the motion. The motion passed unanimously.

8.0 New Business

8.1 Kathleen M. Casacci, DDS (Wheatfield Family Dentistry Phase II)

Ms. Langdon stated that in 2012, the NCIDA assisted Dr. Kathleen Casacci of Wheatfield Family Dentistry with construction of a new dental office facility on Niagara Falls Boulevard in the Town of Wheatfield. Original plans called for leasing of adjacent space in the building to another business. As the practice has grown, it has become necessary to build out this space to accommodate the dental practice. The new section will be comprised of 3 additional treatment rooms and a massage therapy room.

Dr. Casacci is requesting additional sales tax benefits from NCIDA on the remaining buildouts and the associated furniture, fixtures and equipment. There are currently ten (10) existing full-time jobs with plans to hire an additional six (6) new full-time jobs.

8.2 Iskalo Development Corp.

The company was founded in 1988 by Paul Iskalo who is an experienced real estate developer inclusive of commercial projects such as corporate and medical offices, light industrial, hospitality retail and mixed-use. The company is under contract to purchase 57 Canal Street in Lockport from the City.

Ms. Langdon stated that the building consists of 3 floors and the property surrounding the building was remediated under the Brownfield Cleanup Program and an additional renovation to the building was completed.

The proposed project involves further renovation of the building's interior and exterior improvements. The company is requesting a five (5) year Opportunity Zone PILOT and sales tax and mortgage recording tax abatements. The company has twenty-six (26) full-time employees with eighteen (18) new jobs to be created.

8.3 Platters Chocolates

Ms. Langdon stated that the company plans to lease space in the Wurlitzer Industrial Park located on Niagara Falls Blvd. in North Tonawanda. Some of the space will be dedicated to a retail store and café. The company has previously operated in a facility on Oliver Street in North Tonawanda which, over time, has been expanded. Sales have increased by 60% over the past three years and the company requires more space to add a second production line and expand its retail presence.

The expansion will result in more visibility and the accommodation of tour buses. Visitors will be able to watch the behind-the scenes chocolate making process. The new facility will also allow the manufacturer to produce their product year round. Currently there are twenty-eight (28) full time employees with plans to hire twenty-three (23) new full-time jobs.
