Buffalo Fuel has been approached by another company to leave a large portion of their property located at 4870 Packard Rd, Niagara Falls, NY. The new company will be able to retain approximately 8 jobs while creating another 7 jobs by leasing BFC's facility, rather than looking to do this out of the Niagara County area, or the state of New York. In order to provide room for this new company, BFC will be forced to move their shop to Hyde Park Blvd. This facility is located close enough to our existing establishment on Packard Rd. that it should not create any disruptions in the flow of business. However, unless we are able to offset the cost of the relocation with some financial assistance, we may be forced to look outside of Niagara County to transplant Buffalo Fuel Corp. in its entirety.

G.
