It has been vandalized and left vacant for the few previous years with only the dental office in operation. SJI Properties wants to bring this landmark back to its former glory through providing residential housing opportunities and commercial spaces for local businesses to embed themselves in the surrounding community. The project will focus on rehabilitation of 42 apartments and 5 commercial spaces, adding to the revitalization of the area. The property sites at the corner of 3rd and Main Street in the center of the rejuvenation efforts happening along Main Street.
